



GENERAL REMOUNT NON-STRUCTURAL WARRANTY POLICY

VCI Emergency Vehicle Specialists (VCI) hereby warrants to each Remount purchaser, retro-fitted by VCI that all non-structural material and workmanship incorporated by VCI during the remount process shall be free of defects.

The warranty extends to standard VCI features incorporated during the remount process and published VCI options.

The term of the warranty shall be a period of (2) years from the date of remount (as noted on the Final Manufacturer's Certification Plate) or until the vehicle has been driven 24,000 miles.

VCI Emergency Vehicle Specialists extends no warranty with respect to the chassis, to components or equipment manufactured, assembled or installed by the chassis manufacturer or any item manufactured (including tires, batteries, bulbs, seats, upholstery, and other wear items) or to any components or equipment manufactured by others and installed by VCI, all of which are the subject of warranties issued by other parties. VCI will assist each owner in processing any claims under such other warranties.

The warranty is conditioned upon i) normal use and reasonable maintenance of such vehicle and covered attachments as recommended by VCI, ii) prompt written notice of all defects to VCI or its then authorized dealer in the owner's area, and iii) all repairs, modifications, and additions thereto being performed by VCI or a party authorized by it. This warranty does not extend to, and will not cover, defects or conditions resulting from misuse, negligence, accident, or overloading beyond applicable weight rating. Upon the failure to satisfy any such conditions, this warranty shall become void and unenforceable.

Should repairs become necessary under the terms of this warranty, the extent of that repair shall be determined solely by VCI and shall be performed solely by VCI or a repair facility designated by VCI. The expense of any transportation to or from such repair facility shall be for the account of the owner and is not covered by this warranty.

VCI Emergency Vehicle Specialists reserves the unrestricted right at any time and from time to time to make changes in the design of, and/or improvements on, its products without thereby imposing any obligation on itself to make corresponding changes or improvements in or on its products therefore manufactured.

YOUR RIGHT TO SERVICE AND REPLACEMENT OF PARTS ON THE TERMS EXPRESSLY SET FORTH HEREIN ARE YOUR EXCLUSIVE REMEDIES AND NEITHER THE MANUFACTURER NOR ANY OF ITS DEALERS SHALL BE LIABLE FOR DAMAGES, WHETHER ORDINARY, INCIDENTAL OR CONSEQUENTIAL.
